Christmas safety

There are many things that make the holidays jolly: Family, good food and a wonderful present. There are many things that make the holidays not so jolly: Loved ones not being home for the holidays, finding the right Christmas present, preparations not going as smoothly as desired, or an accident can make holidays stressful.

This holiday season my son will be joining us in spirit once again. Last year he was in Japan, this year the Navy has sent him to the Persian Gulf. My Christmas wish for him is that he stays safe. The REMC Christmas wish is that all our members and their families stay safe. In the Christmas safety spirit we are bringing you a multitude of Christmas safety tips.

Tree safety

- A real tree should not lose green needles when you tap it on the ground.
- Cut 1 inch off the trunk to help absorb water.

- Leave the tree outside until ready to decorate.

- The stand should hold at least 1 gallon of water.

- A 6 foot tree will use 1 gallon of water every two days.

- Mix a commercial preservative with the water.

- Check the water level every day.

- Secure the tree with wire to keep it from tipping.

- Keep tree away from floor heaters, fire places, or other heat sources.

- Use only UL-listed lights, and no more than 3 strands linked together.

- Use miniature lights — which have cool-burning bulbs.

- Turn off the Christmas lights when you sleep, or if you leave your home for very long.

- Never use candles, even on artificial trees.

- Clean the tree stand to improve the trees water intake, use one capful of bleach to a cup of water.

- Dispose of the tree properly.

- **NEVER BURN A REAL TREE IN THE FIREPLACE.**

Home safety

- Install a smoke detector or new batteries in the one(s) you have and TEST it.

- Use only outdoor lights outside your home.

- Examine light strings each year; discard worn ones.

- Fasten the bulbs securely and point the sockets down to avoid moisture build up.

- Connect no more than three strands together.

- Never use indoor extension cords outside.

- Avoid overloading wall outlets and extension cords.



- Keep outdoor electrical connectors above ground and out of puddles and snow.

- Unplug light string before replacing a bulb.

- Review the original package to verify proper wattage and voltage.

- When connecting light strands, wrap a plastic bag around connections and tie ends with teflon tape.

- Never use electric lights on a metallic tree, use colored spot lights.

- Make sure trees hung with Christmas lights are not touching power lines.

- When using candles, place them a safe distance from combustibles.

- Place candles in sturdy containers. Remember, hot wax burns kids.

- Extinguish candles prior to going to bed.

- Dispose of fireplace ashes into a metal container until cold.

- After parties, check around and under sofa and chair cushions for smoldering cigarettes. (Provide lots of ash trays)

- Install at least one carbon monoxide detector in your home.

- Have an operable fire extinguisher readily available.

Safety gift ideas

Put together a gift basket containing one or more of the following items:

- Three smoke detectors and batteries.

- A quality fire extinguisher.

- A flashlight and batteries or light sticks.

- A first-aid kit.

- A carbon monoxide detector.

- A mobile phone.

- A second floor escape ladder.

- Emergency kit- energy bars, water, battery radio, flashlight/light sticks and a first-aid kit packed in a small travel bag.

Robbie's rugs not only cover walls in Jay

Floral designs are Robbie's favorites. Robbie's rugs are not your typical rectangular shaped rugs that lie on the floors. These decorative rugs vary in size and shape. Rectangular rugs are easier to make because they can be sewn on the machine. If a customer requests a rug that has a unique shaped outline Robbie has to sew the edges by hand.

Rugs vary in price depending on the cost of the carpet, amount of hours in drawing the rug, and amount of time making the rug. Rug terminology includes backing, binding and grippers. Other terms used when speaking of Robbie's rugs would be unique, beautiful, and exquisite. Giving one of Robbie Ray's original creations as a Christmas gift would be wise.

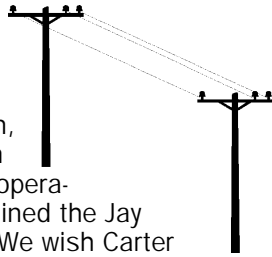

Christmas safety for dogs

Angel hair: This is made from spun glass, it can irritate the skin, cause cuts and damage the eyes. If eaten it can cause intestinal blockage.

Artificial snow, flocking: These are possibly poisonous, can cause digestive upset or be a respiratory irritant if inhaled. Spray only the upper corners of high windows.

Candles: Flame or dripping wax can burn dogs and cats or singe their whiskers or hair. Also, they are a fire hazard if the pet knocks them over. Save candles for the dining room table, and don't burn them near an unattended pet.

Electric cable: Dogs and cats can be shocked, burned or electrocuted by chewing on cable. It is safer to run cables through PVC piping, cover with rugs, or secure to the floor by placing behind or beneath heavy furniture.

Decorations: Glue, rubber bands, staples, string, tacks and tape can cause mild pain, serious complications, or death if swallowed. Store them in a secure place. Discard used items when decorations are removed.

Fire/fireplaces, including ashes, popping wood: These can cause bronchial irritation, burns, skin irritation and digestive distress. Keep a fire screen in front of a fireplace while in use.

Food: Bones can cause choking, internal punctures, possibly death.

Chocolate can cause theobromine poisoning, which is an over stimulation of the nervous system, and may be fatal. Chocolate also causes vomiting, diarrhea, tremors, hyperactivity and seizures. Fatty, spicy, or sweet foods lead to gastric upset, dehydration and pancreatitis. Burns and mouth or throat ulcerations can result from hot food. Do not share your holiday goodies with your pets. If you can resist give a healthy treat. Keep your dog out of the dining area and feed it its regular dinner while you eat. Do not leave cooking food unattended or set hot dishes near edge of stove or counter. Do not leave sweets or other snacks where your dog can reach them.

Guests: They add to the noise, confusion and stress for your pet who will be put out of its routine. Pets can be stepped on, or unsupervised children can injure them. Pets can escape when visitors come and go. Guests are more likely to feed your pets and "just a little bite" adds up to quite a lot of food. Always advise your guests not to feed your pets. If your guests are uncomfortable around your dogs and cats, or if extra activity causes your pet anxiety, board it for the holidays. Your cat and dog should sleep in a regular spot. If it is where it will be distressed, move the pet to a quiet place where it will be comfortable.

Decorative lights: Cats and dogs can become tangled in the strands, leading to burns and cuts. They can create the same hazards as electric cables. Costumes and dressing

up: Never dress up cats and dogs as costumes can cause choking and strangulation. Plants, holly, ivy, mistletoe and poinsettia: These plants range from mildly upsetting to extremely toxic. If eaten they can cause gastrointestinal irritation, nausea, vomiting, diarrhea, drooling, coma, central nervous system or cardiac problems or even death.

Gift wrapping: Ribbon, trim polystyrene foam packaging, wrapping foil and paper are dangerous if eaten by your pet. Always wrap packages in an area away from your pet. Collect and discard all the waste. Any wrapping paper and supplies you are not using, put away. If you have any gifts for your dog, use plain brown paper, wrap loosely and supervise unwrapping.

Live trees: Place the tree in a room away from the cat or dog. To stop the tree from falling over, place a hook in the ceiling and use some nylon yarn. Tie the top of the tree with the nylon and then secure this to the ceiling. By using this

system the tree cannot fall over. — *The pet safety tips are brought to you by Dave the Dog Man.*

The best tip I can give any family is to reduce the stress level of your wife or mother. This will guarantee a happy holiday. Board of director election petitions available

The 2004 annual meeting is scheduled for April 17. There are three directors' seats up for re-election. Those seats are District 2, District 6, and District 9. Richard Nixon represents district 2. Nixon's district covers those areas in Greene, Jefferson, Richland, Wayne and Pike townships in Jay County bounded on the east by S.R. 27, on the south by the Jay-Randolph County line, on the west by S.R. 1, on the north by S.R. 26.

Ron Smithson represents district 6. Smithson's district encompasses the entire Randolph County area.

Diane Antrim represents district 9. District 9 is all of the area that the Jay County REMC serves in Adams County east of U.S. 27. This area is bounded on the west by U.S. 27, on the east by the Indiana-Ohio state line, on the north by Adams County Road 450 N. and on the south by the Jay-Adams County line.

Interested parties need to pick up a petition at the Jay County REMC after Dec. 1, and return the petition by Jan. 12, 2004. Any qualified member of the Jay County REMC may run for a seat on the board of directors by getting 15 Jay County REMC members to sign a petition of support.

To qualify you must take electric service at your primary residence in the district that is being contested in order to be an eligible candidate. The member who signs the petition does not have to live in the district up for election.
